

RELEASE AND WAIVER

Camp Tuttle, Episcopal Church

The novel coronavirus (COVID-19) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and believed to spread mainly from person-to-person contact. Even if CAMP TUTTLE, Episcopal Church complies with all applicable laws, regulations, rules, and orders, you, your child(ren), and other family members may still become infected with COVID-19 arising from participation in the program described below by you and your child(ren). Further, participation in any such COVID-19. Also, such participation could increase for those members of your family who are "high-risk individuals," as defined by the "Utah Leads Together III" plan released by the Utah Economic Response Task Force on May 20, 2020, the risk of serious illness, injury or death from contracting COVID-19.

AGREEMENT

In consideration of being permitted to participate in meetings at CAMP TUTTLE, Episcopal Church, I hereby agree to comply with all safety protocols, rules, regulations and guidelines published by the Church, and with all governmental laws, rules and regulations, as modified from time to time. If I fail to comply with the any of the foregoing, I understand that permission for me to participate will be immediately withdrawn. I also agree to follow all posted instructions and verbal instructions by the Church staff with respect to any of the foregoing.

I further agree and Affirm that neither I nor any member of my household:

- Currently has, or has experienced in the last 14 days any of the following symptoms of COVID-19: fever; fatigue; dry cough; or difficulty breathing.
- Has been diagnosed with COVID-19 within the past 30 days.
- Has knowingly been exposed to anyone diagnosed with COVID-19 within the past 30 days.
- Has traveled outside of the United States or to any city considered to be a "hot spot" for COVID-19 infections within the past 30 days.

RELEASE AND WAIVER:

By signing this Release and Waiver, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating in any meeting or program at CAMP TUTTLE, Episcopal Church (the "Church") and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 by participating in any of such programs may result from the actions, omissions, or negligence of myself and others, including, but not limited to, employees, officials, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks related to exposure to COVID-19 and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at, or participation in, such programs("Claims").

I hereby release, covenant not to sue, discharge, and hold harmless the Church, the Episcopal Diocese of Utah (the "Diocese"), and their employees, officials, volunteers, agents, and representatives, of and from the Claims, including all liabilities, causes of action, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this Release and Waiver applies to any Claims based on the actions, omissions, or negligence of the Church and the Diocese, and their employees, agents, volunteers and representatives, whether a COVID-19 infection occurs before, during, or after participation in any program or activity.
